# Project Management Plan

---

- A (contractor) Project Management Plan is not a DOE CD-1 requirement, but it is customary and (I believe) good practice to write one.
- For DUNE and LBNF we need:
  - A description of how LBNF will do business internally to the project
  - A description of how DUNE will do business internally to the project
  - A description of how DUNE and LBNF will work together, and of the international coordination and advisory functions that are outside the DOE system

# Project Management Plan

---

- DOE plans to manage as a single project at their level
  - LBNF, a DOE project with international participation
  - US-DUNE, the US(DOE)-funded part of the international DUNE project

The DOE Federal Project Director (Pepin Carolan) will be responsible for this (pair of) project(s)

- The FPD will prepare a Preliminary Project Execution Plan (PPEP) for the CD-1 refresh covering this scope
